

**BILL OF RIGHTS FOR DATA PRIVACY AND SECURITY -**

**SUPPLEMENTAL INFORMATION FOR CONTRACTS THAT UTILIZE PERSONALLY IDENTIFIABLE INFORMATION**

Pursuant to Education Law § 2-d and Section 121.3 of the Commissioner’s Regulations, the educational Agency (EA) is required to post information to its website about its contracts with third-party contractors that will receive Personally Identifiable Information (PII).

They must be approved for membership by CHP. The information is entered by the student in the online member application document. The students enters their name, address and birthdate. All information is provided voluntarily.</p>

**CONTRACTOR'S DATA PRIVACY AND SECURITY PLAN**

The Educational Agency (EA) is required to ensure that all contracts with a third-party contractor include a Data Security and Privacy Plan, pursuant to Education Law § 2-d and Section 121.6 of the Commissioner's Regulations. For every contract, the Contractor must complete the following or provide a plan that materially addresses its requirements, including alignment with the NIST Cybersecurity Framework, which is the standard for educational agency data privacy and security policies in New York state. **While this plan is not required to be posted to the EA's website, contractors should nevertheless ensure that they do not include information that could compromise the security of their data and data systems.**

The personal information collected through the CHP Website and during our application process is maintained in a manner consistent with current industry standards. Personal information resides on servers that are protected by physical and electronic safeguards and shields.
2	Specify the administrative, operational and technical safeguards and practices that you have in place to protect PII.	Personal information is encrypted using secure socket layer technology (SSL) to prevent unauthorized parties from viewing such information when it is transmitted to us.

Annual training is completed for all CHP employees with regard to data security. We also are required to complete data security and sexual harassment modules provided by BOCES.
4	Outline contracting processes that ensure that your employees and any subcontractors are bound by written agreement to the requirements of the Contract, at a minimum.	Employment agreements are in place.

The CHP Website has security measures in place to protect the loss and misuse of the information under CHP's control. However, you should keep in mind a breach of security may occur as no Website is fail proof. CHP uses cookies to track session status only. Cookies are not used to disseminate information.
6	Describe how data will be transitioned to the EA when no longer needed by you to meet your contractual obligations, if applicable.	As noted above, CHP membership requires PII for approval of member applications. The information is entered and provided voluntarily by the student. It is not transmitted or received from BOCES.
7	Describe your secure destruction practices and how certification will be provided to the EA.	Secure destruction practices follow current industry standards.
8	Outline how your data security and privacy program/practices align with the EA's applicable policies.	CHP complies with FERPA and State Laws relating to to data privacy in education. However, all PII provided to CHP is given voluntarily by the student to be approved for CHP membership.
9	Outline how your data security and privacy program/practices materially align with the NIST CSF v1.1	CHP follows industry standards in data security, privacy programming and cyber security.

## Western Suffolk BOCES Education Law §2-d Bill of Rights for Data Privacy and Security

Parents (including legal guardians or persons in parental relationships) and Eligible Students (students 18 years and older) can expect the following:

1. A student's personally identifiable information (PII) cannot be sold or released for any Commercial or Marketing purpose. PII, as defined by Education Law § 2-d and the Family Educational Rights and Privacy Act ("FERPA"), includes direct identifiers such as a student's name or identification number, parent's name, or address; and indirect identifiers such as a student's date of birth, which when linked to or combined with other information can be used to distinguish or trace a student's identity. Please see FERPA's regulations at 34 CFR 99.3 for a more complete definition.
2. The right to inspect and review the complete contents of the student's education record stored or maintained by an educational agency. This right may not apply to Parents of an Eligible Student.
3. State and federal laws such as Education Law § 2-d; the Commissioner of Education's Regulations at 8 NYCRR Part 121, FERPA at 12 U.S.C. 1232g (34 CFR Part 99); Children's Online Privacy Protection Act ("COPPA") at 15 U.S.C. 6501-6502 (16 CFR Part 312); Protection of Pupil Rights Amendment ("PPRA") at 20 U.S.C. 1232h (34 CFR Part 98); and the Individuals with Disabilities Education Act ("IDEA") at 20 U.S.C. 1400 et seq. (34 CFR Part 300); protect the confidentiality of a student's identifiable information.
4. Safeguards associated with industry standards and best practices including, but not limited to, encryption, firewalls and password protection must be in place when student PII is stored or transferred.
5. 6. The right to have complaints about possible breaches and unauthorized disclosures of PII addressed. (i) Complaints should be submitted to: [dpo@wsboces.org](mailto:dpo@wsboces.org). 7. To be notified in accordance with applicable laws and regulations if a breach or unauthorized release of PII occurs.
8. Educational agency workers that handle PII will receive training on applicable state and federal laws, policies, and safeguards associated with industry standards and best practices that protect PII.
9. Educational agency contracts with vendors that receive PII will address statutory and regulatory data privacy and security requirements.
