# Resolution to Participate in Southampton UFSD SPS22-014 Sound System Parts & Repairs [R]

On motion by Mrs. Herz, seconded by Mrs. Santos, the Board voted unanimously for Resolution to Participate in Southampton UFSD SPS22-014 Sound System Parts & Repairs as follows:

WHEREAS, Section 103 of the General Municipal Law permits Western Suffolk BOCES to purchase apparatus, materials, equipment or supplies or contract for services related to the installation, maintenance or repair of apparatus, materials, equipment, and supplies through the use of a contract let by the United States or any agency thereof, any state or any other county, political subdivision or district therein if such contract was let to the lowest responsible bidder or on the basis of best value in a manner consistent with this section and made available for use by other governmental entities; and

WHEREAS, Western Suffolk BOCES, based on the authority granted in General Municipal Law, Article 5A (Public Contracts), Section 103, desires to participate in Southampton UFSD SPS22-014 Sound System Parts & Repairs, for the purpose of fulfilling and executing its public governmental purposes, goals, objectives, programs

and functions; and

WHEREAS, Western Suffolk BOCES has reviewed the benefits of participating in this program and an analysis is performed, and based on this review which is in accordance with the General Municipal Law, has concluded that participation in the program could result in savings to Western Suffolk BOCES;

THEREFORE, BE IT RESOLVED, that Western Suffolk BOCES is authorized to participate in Southampton UFSD SPS22-014 Sound System Parts & Repairs and that the Board President and/or the Chief Operating Officer or his designee is hereby authorized to execute any and all necessary documents to effectuate participation in Southampton UFSD SPS22-014 Sound System Parts & Repairs.

It is also declared that these projects represent Type II actions and that these projects will have no significant adverse impact on the environment based on the criteria contained in subdivision 617.7c and these are not Type I actions as defined in section 617.4.

WHEREAS, the Original Agreement provides that students entering one of the School's Allied Healthcare Programs may be assigned to a Catholic Health Service Clinic site for training; and

WHEREAS, Section V(G) thereof provides that the Original Agreement may be amended from time to time in writing signed by each of the parties; and

WHEREAS, the parties desire to amend Exhibit A to the Original Agreement to clinical educational opportunities to students in an additional allied health area of study.

WHEREAS, said agreement would be beneficial to the students participating;

NOW THEREFORE BE IT RESOLVED, in consideration of the mutual covenants and agreements set forth herein, Western Suffolk BOCES and Catholic Health Services agrees as follows;

NOW THEREFORE BE IT RESOLVED, the Original Agreement shall remain in effect, except as modified herein, the Original Agreement shall remain in full force and effect and this Addendum shall prevail. Collectively, the Original Agreement and the Addendum shall constitute the agreement.

THEREFORE, BE IT RESOLVED, the Chief Operating Officer be authorized to execute said Addendum to the

Original Agreement with Catholic Health Services of Long Island. This Addendum to Affiliation Agreement will become effective November 1, 2024.
